	<p><u>Chairman's Welcome and Public Forum</u> – the Chairman welcomed those present, with an especially warm welcome to members of the public, who were present.</p> <p>Mr Ian Day addressed the Meeting regarding the Beach Break Live event. He referred to the public meeting and the 130 complaints received by NCDC. He felt the event was a public nuisance, and referred to the anti-social behaviour and number of crimes linked to the event. He sought the Council's support in requesting NCDC to review the entertainment licence. Cllr. Mould said that when the licence was granted the views of this Parish Council was not sought, because the event was held in St Minver Highlands Parish Council area. She advised Mr Day that the matter will be discussed later and the views of the Council will be made known to him. Mr Day wondered if the public consultation process involved was adequate, in particular in bringing it to the public's attention.</p> <p>Ms Mably said at the end of the day the Beach Break Live event was only for three days of the year.</p> <p>Ms Clare Owen and Ms Natalie Mably from the St Minver Pre-School spoke regarding their draft lease. They indicated they are happy for the lease to be for 6-years only. Ms Mably queried the clause barring the keeping of live birds and animals. It was AGREED the clause should remain, but if they wished to have a small pet then permission could be granted on an ad hoc basis. It was confirmed the Council would have no objection to children's parties being held, however, it was pointed out that a public entertainment licence might be needed. Ms Mably queried if a guarantor was necessary as the rent was so low. It was felt this was a legal requirement and should remain. It was clarified the Pre-School will be responsible for the boundary fence around their area.</p> <p>The Clerk apologised to the Meeting, the numbering on the agenda was wrong. This will be corrected on the Minutes.</p>

NO OBJECTION.</p> <p>f. 2008/01221, <i>Trefelix, Trewiston Lane</i> – FP, demolition of existing stables and erection of garage. NO OBJECTION.</p> <p>g. 2008/01254, <i>White Lodge, Polzeath</i> – FP, demolition of existing holiday accommodation and erection of residential dwelling house. It was noted a previous application to demolish and erect replacement holiday accommodation was withdrawn. NO OBJECTION.</p>	
118/2008	<p><u>Financial Matters</u></p> <p>a. <i>Accounts for Payment</i> – schedule No.2008/9-4, to the value of £1,859.26 was APPROVED for payment.</p> <p>The Clerk reported the Audit Commission had requested additional information, which has now been provided.</p> <p>Cllr. Mould reported the toilet seats have been ripped out in the gentlemen’s toilets. It was AGREED to request a quotation to replace the seats, from Mr Meneer. It was AGREED that each Member will visit the toilets before the next Planning Meeting, with a view to deciding what needs to be done to improve them.</p> <p>b. <i>Budget Monitor</i> – copy was circulated at the Meeting.</p> <p>c. <i>Grant Request</i> – Members felt unable to contribute towards the cost of collapsible music stands for the TrePolPenBells Bell Ringers, because any spare funds are needed for the children’s play area.</p> <p>d. <i>Rock Sand Dunes</i> – Members were willing, in principle, to make a contribution towards the cost of materials to prevent further erosion of the sand dunes, but wished to know the full costs involved.</p>	<p>Clerk</p> <p>All Members</p> <p>Clerk</p> <p>Clerk</p>
119/2008	<p><u>Traffic Matters</u></p> <p>a. <i>Highways Working Group</i> – Minute 96a/2008 refers. No response has been received from Mr David Short or St Minver Highlands Parish Council regarding the creation of a working party. It was noted that St Minver Highlands Parish Council has appointed three representatives. The Clerk to seek further information.</p> <p>b. <i>Wadebridge Car Park</i> – Minute 104e/2008 refers. Wadebridge Town Council has written to say the decision to lock the car park was taken, following complaints from nearby residents. Anyone finding themselves locked in the car park now can ring a number to be released (for a fee).</p> <p>c. <i>Missing “No Parking at any Time” Sign</i> – Minute 104f/2008 refers. Mr Paul Allen, Highways, advises a sign is not needed to support the double yellow lines, opposite the Mariners’ Pub, to be replaced. He refers Members to the Civil Parking Enforcement team.</p> <p>d. <i>Footway, Rock Road</i> – Mr Paul Allen, Highways, advises work on the Cocklawelva to Stoptide footway is due to commence Oct/Nov.</p>	<p>Clerk</p> <p>Information</p>
120/2008	<p><u>Trewint Playing Fields</u> –</p> <p>a. <i>Children’s Play Area</i> – Minute 97a/2008 refers. Cllr. Gibson reported there is £7,000 already pledged to this project. She produced an example of some play equipment, suitable for most ages, which, together with safe surfacing will be circa £11,500. It was AGREED to make the £4,604 allocated towards the “policing” of street traders available to the project. Cllr. Gibson will seek further funding.</p>	

	<p>b. <i>St Minver AFC</i> – Minute 97b/2008 refers. It was AGREED to accept the amendments recommended by Mr Charles Rushforth (Chisholms Solicitors). The Licence was duly signed and witnessed and will be sent to St Minver AFC for their signature.</p> <p>c. <i>St Minver Pre-School</i> – Minute 97c/2008 refers. Item dealt with under the Public Forum. 121/2008	<p><u>Polzeath</u> –</p> <p>a. <i>Polzeath Toilets</i> – the letter of complaint, regarding the area around the public toilets, was noted.</p> <p>b. <i>Beach Break Live</i> – Cllr. Rathbone reported that the entertainment licence will be reviewed, following the number of complaints. The level of noise was the cause of most concern. Closing the event early wasn’t thought to be the answer – where would 5,000 young people go then? The Clerk to write to NCDC to add Members’ support for a review of the licence, in view of the strong feelings expressed about the noise levels.</p> <p>Cllr. Gisbourne arrived at this point.</p> <p>c. <i>Polzeath Beach Partnership</i> – copy of the revised Action Plan was made available at the Meeting. Cllr. Mould reported the “mosquitoes” are in place, concern about the public benches was discussed earlier. The Action Plan has been placed on our website.</p> <p>Cllr. 122/2008	<p><u>Environmental Matters</u> –</p> <p>a. <i>Daymer Bay Beach Cleaning</i> – Minute 98a/2008 refers. Mr Mike Beckett, NCDC advises it will be possible for the Trebetherick Residents’ Association to manage the grant and this avenue is being pursued.</p> <p>b. <i>Rock Beach Cleaning</i> – Minute 81c/2008 refers. It was AGREED to continue to act as middle-man in respect of the Rock beach cleaning grant. The Clerk to advise Mr Mike Beckett.</p> <p>c. <i>Rock to Brae Hill</i> – Minute 98a/2008 refers. Cllr. Mould reported she had spoken to Mr Jolyon Sharpe, NCDC Beach Ranger, who has agreed to organise a clean up of the beach. She will pursue.</p> <p>d. <i>Footpaths</i> – two complaints have been received, regarding overgrown footpaths. (1) Path from the middle of Daymer Lane to the golf course. (2) Path from Trefresa to Treverrow/Treverra and from Trefresa towards Carlyon. Cllr. Mould reported she had met with Mr Danny Burnett, Footpath Contractor. Unfortunately, he is unavailable to do an extra cut before August. However, he is willing to work with the Council to identify those paths which need additional cuts.</p> <p>Cllr.
